



## NCISAA Spectator Policy

### Policy

**Current Policy:** No Fans/Spectators at any NCISAA games or contests at this time. Only essential personnel are permitted to attend games or contests.

### Definitions

**Definition of Fan/Spectator:** A non-essential person who attends to watch a game or contest

**Definition of Essential Personnel:** See Return-To-Play Minimum Standards

**Definition of Bus Driver:** Any person who transports a student-athlete to a game or contest

**Definition of Public Facilities:** Any facility not owned by a member school that has unrestricted access

FAQs	Answers
<b>Where do bus drivers park?</b>	Designated area per the Host team
<b>Are bus drivers permitted to leave their vehicle?</b>	No
<b>What if the bus driver needs to use the restroom?</b>	Leave the premises in your vehicle and then return.
<b>We play at a public facility, how do we manage fans/spectators in a public space?</b>	If fans/spectators or parents of your players show up at a public facility, the expectation is that your game day management/coach will ask them to leave.
<b>Does game day management have any responsibility for people who park off of school property to watch games or contests?</b>	If fans/spectators or parents of your players show up at a public space near your facilities, the expectation is that your game day management/coach will ask them to leave.
<b>Can fans/spectators remain in their vehicle, on school property and watch the game or contest?</b>	No, not at this time.
<b>Can the media attend games or contests?</b>	Yes, per the host school's decision.
<b>Will this policy be re-evaluated?</b>	Yes, the fan/spectator policy will continue to be re-evaluated throughout the Fall season.

The NCISAA has created a plan to move toward allowing spectators.

This is a plan. It's a good plan. Certainly not one that appeals to "everyone", however...our kids are playing... we will rejoice!

There are nearly 100 schools in the NCISAA, therefore this plan considers all schools circumstances as some have chosen a more restrictive path of opening for athletics.

**Stage 1-** Begins Thursday, October 1<sup>st</sup>. The host team may allow 2 legal guardians per senior on the host team roster. No siblings, or other relatives.

**Stage 2-** Begins when the NC Governor allows for larger gatherings therefore there is no "specific" date yet. Expands to include 2 legal guardians per athlete on the roster of the host team. No sibling or other relatives.

**Stage 3-** No specific date yet. Expands to includes 2 legal guardians of the visiting team to attend.

**Stage 4-** No specific date yet. Expands to include siblings, relatives and students of host team.
